

**Luxembourg Hosts 15th IHE-Europe 2015 Connectathon and
First IHE International Conformity Assessment.**

From April 20 – 24 2015, Luxembourg will be hosting the IHE-Europe Connectathon, for the first time in its 15 year history. It will also be the first time that the Connectathon has, running in parallel (22-24 April), the IHE International Conformity Assessment Program undertaken by an established ISO17025 accredited testing laboratory – Kereval. Conformity Assessment delivers additional testing rigour and increased confidence of compliance to those procuring (<http://ihe-europe.net/ihe-services/conformity-assessment>).

The IHE Connectathon is a “test marathon” that provides all companies, large and small, the opportunity to test their products in a structured environment across a variety of domains including Radiology, Cardiology, Pathology, Patient Care Devices, Patient Care Coordination, Pharmacy, Laboratory, Dental and crucially IT Infrastructure, along with those of their peer vendors. Real world clinical scenarios following IHE Integration Profile specifications are used.

Almost 80 companies will join the Connectathon testing this year, bringing together more than 100 systems and over 300 participants for a full week of intensive testing. This increase clearly shows how important interoperability is across the healthcare spectrum in Europe.

“Once again we have a number of new SMEs attending and welcome back a number of the traditional healthcare companies that have decided to return this year, along with those regulars that are seemingly always present. I expect a particularly successful, hard-working, but rewarding, week for all those involved”, said Eric Poiseau, IHE-Europe’s Technical Coordinator of the Connectathon testing. “I would particularly like to thank our volunteer Monitors, who have again surpassed themselves to be ready to judge test results. Without their presence it would be a very different event and one severely lacking their expertise”, he added.

Companies attending, that successfully pass their testing requirements, will be recorded on the IHE International Connectathon Results data base (<http://connectathon-results.ihe.net>), which is particularly important both to vendors and to the buying community across Europe, as part of their decision making process. For systems that are commercially released the vendor will produce an IHE Integration Statement available in the IHE Product Registry (<http://product-registry.ihe.net>).

All vendors, new, returning and regular, are encouraged to look at the recently updated IHE-Europe White Paper (<http://www.ihe-europe.net/news-and-press/publications>). It gives a considerable amount of background information about the Connectathon, it is also invaluable content when considering attendance at next year’s IHE-Europe Connectathon, which will take place in Bochum, Germany, April 11-15, 2016, which will also feature the 2016 IHE International Conformity Assessment Program.

2015 also sees the Med-e-Tel International eHealth, Telemedicine and Health ICT Forum, running 22-24 April inclusive, in rooms adjacent to the Connectathon. It will include a special IHE Symposium – Interoperability in Practice for eHealth and mHealth – a half day event that will be addressed initially by the Luxembourg Prime Minister and Minister of Health, culminating in a guided visit to the Connectathon floor.
