Jürgen Brandstätter also finds time to participate in academic and research activities with the Medical University of Vienna where his collaboration on the 'Unified Patient' project has been looking at webbased linking of problem orientated medical knowledge and patient data to enhance the quality of patient's treatment at various stages of the healing process.
