

EURO-CAS key goal


EURO-CAS is a European project with the objective to develop the sustainable Conformity Assessment Scheme for Europe (CASforEU), to promote the adoption and take-up of interoperability testing of eHealth solutions against identified eHealth standards and profiles defined in the Refined eHealth European Interoperability Framework (ReEIF)









Define a sustainable scheme with processes and content (CASforEU)

Meet the requirements at the European and national/regional levels

Provides operational guidance for eHealth initiatives to implement and adapt CASforEU to local needs

Keep consistency with existing international initiatives such as IHE CAS and PCHAlliance CAS, and SDOs

Use accredited test labs and ISO/IEC 17067, ISO/IEC 17025 and other applicable ISO/IEC standards

Create an open organization for members to maintain and evolve CASforEU

Pragmatic approach... and now to work!

- EURO-CAS design an original CASforEU for eHealth in interoperability sufficiently flexible to
 - Provide a first set of profiles that can be extended by new use cases and other domains (cybersecurity for examle);
 - Allow recognition at the International level (standards and profiles) and national/regional levels;
 - To propose a open and transparent organization based on consensus among its members;
 - Develop Digital Single Market in Europe
 - Reduce effort and time to market
- Operationalisation of EURO-CAS ready to start thank to all additional assets:
 - Implementation guide
 - Business Plan
 - Governance for the maintenance
 - Deployment plan







EURO-CAS for future usage

- EURO-CAS proposes an organization that centralizes common needs at the European level and will facilitate quick adoption of existing standards and their implementation in solutions and products delivered by suppliers → more time to develop new features in products
- EURO-CAS can be used for assessing European Electronic health Record format exchange
- EURO-CAS organisation will support and educate Europe, countries and regions in their own assessment/certification process
 - → maturity of the country and reduction of costs
- New market opportunities for test laboratories
